# ST. AUGUSTINE PORT, WATERWAY & BEACH DISTRICT MINUTES OF REGULAR MEETING Thursday, September 16, 2021

The regular meeting of the St. Augustine Port, Waterway & Beach District was held at the St. Augustine Beach City Commission Meeting Room, 2200 AlA South, St. Augustine Beach, Florida, on Thursday, September 16, 2021.

### 1. CALL TO ORDER

Chairman Matt Brown called the meeting to order at 3:00, p.m.

### 2. PLEDGE OF ALLEGIANCE

The Pledge of Allegiance to the flag of the United States of America followed.

### 3. Invocation

Commissioner Tom Rivers gave the Invocation.

## 4. ROLL CALL

Chairman Matt Brown, Vice-Chairman Chris Way, and Commissioners Tom Rivers, Sandy Flowers, and Jane West were present. The meeting was also attended by Secretary-Treasurer Elyse Kemper and Clay Meek, General Counsel for the District.

#### 5. ADOPTION OF AGENDA

A motion to approve the agenda was made by Commissioner Rivers, seconded by Commissioner West, and passed by a 5-0 vote.

# 6. PUBLIC COMMENT

Linda Ginn of the Friends of the Summer Haven River requested that the District request Taylor Engineering to seek a permit for sand fencing to allow for a cheaper cost for the project and that a letter seeking renewal of a permit for sand placement and dredging from the Army Corps of Engineers be signed off upon by the District. It was agreed that this would be discussed at the next meeting.

### 7. GOVERNMENT REPRESENTATIVE COMMENTS

Jim Piggott appeared on behalf of the City of St. Augustine. Mr. Piggott indicated that St. Augustine had been named a top 10 boating community. Mr. Piggott also indicated that bids for Salt

Run pilings to be handled by the City at the request of the Port Authority had been opened, two entities bid, and one was selected and would possibly be handling some pylon replacements for the City and would be available for the District, if requested. Mr. Piggott also indicated that Officer Pat Harvey was attending a marine law enforcement course.

Sergeant Josh Underwood of the St. Johns County Sheriff's Marine Unit appeared next. Sergeant Underwood briefly mentioned that a kayak had sunk and was saved by the airboat the District had helped fund. Sergeant Underwood also mentioned the need for renewal of the interlocal agreement regarding overtime hours funded by the A Motion to continue operating under the interlocal agreement funding some overtime hours was made by Chairman Brown, seconded by Commissioner West, and carried by a 5-0 vote. Sergeant Underwood then discussed a joint agency funding request for 10 (ten) Accurad PRD devices to be primarily used to detect radioactive devices. The devices are \$1,350.00 each, for a total of \$13,500.00 to be shared and used by City of St. Augustine and County fire, rescue, and law enforcement agencies. discussion, Sergeant Underwood was joined by Eric Helstrom and Chris Pacetti of the St. Augustine Fire Department and Aaron Braddock of the St. Johns County Sheriff's Office. All of these individuals described and explained the concern to be addressed by the requested devices and how such devices help to prevent lowlevel terrorist radioactive devices. It was requested that more information regarding the need for the devises, such as port security risk assessment information, be provided and the request would be further considered at the next regular District meeting.

Sydney Lindblad and Nathan Otter of St. Johns County Parks and Recreation Department briefly presented and indicated that beach season was wrapping up and that it had been a good season. Mr. Otter indicated that a representative of public works was not available for the current meeting, but would come before the Port District in a subsequent meeting to give an overview of the projects coming up.

Steve Zukowski, Patrol Supervisor Lieutenant, of the Florida Fish and Wildlife Conservation Commission ("FWC") spoke regarding several matters. The presentation included a history of the issue of a damaged sailboat at the seawall on Dolphin Drive. The boat had been declared derelict while in public waters, but the boat

got moved to the private property and moored to the seawall, which makes it a civil issue between the boat owner and seawall owner as it is considered trash on the private property. Greater money is going into the at-risk derelict boat program in an effort to avoid boats going into derelict status. With this, the third citation for boats nearing and/or reaching derelict status will be a criminal violation.

### 8. SECRETARY-TREASURER'S REPORT

Secretary-Treasurer Kemper delivered the financial report. As of August 31, 2021, the District spent: \$3,054 for overtime hours of police officers of the City of St. Augustine and \$11,166 for overtime hours of deputies of the St. John's County Sheriff's Department. The State Board of Administration account had a balance of \$23,165. The Operating Account had \$235,489 as of August 31, 2021. The money market account had \$1,500,000 in the reserve for projects and \$986,239 in addition. Taxes received as of August 31, 2021, were \$584,140, which was \$740 greater than budgeted for the fiscal year due to interest and fees.

#### 9. APPROVAL OF MINUTES

A motion to approve the minutes of the August 17, 2021, regular meeting was made by Commissioner Rivers, seconded by Vice-Chairman Way, and passed by a 5-0 vote.
